# A history of how hope has changed the world

Over the years, our faith and hope have united us, but faith and hope alone are not enough to put poverty in the past. As a community, we have a history of turning our hope into action to create lasting change for people living in poverty.

It's incredible to see what we've achieved together so far. From organising the first Christian Aid week in 1957, to helping bring about a historic agreement at COP27 in 2022, with the establishment of a Loss and Damage fund.

A gift in your Will can enable us to continue transforming hope into action, ensuring that everyone can live a full life, free from poverty.

# 1950s

In the 1950s, we helped establish the Voluntary Service Overseas (VSO) programme to enable young people to make a difference.

## 1960s

In the 1960s, we addressed racism and poverty in the US, and advised Martin Luther King while he was in the UK.

# 1980s


In the 1980s, we helped deliver food to communities in crisis during the famine in Ethiopia, and to those experiencing drought in Mozambique.

Together, we supported the creation of the Southern African Coalition, to demand an end to apartheid.



# 1990s

In the 1990s, we helped to challenge the stigma and discrimination experienced by people living with HIV in sub-Saharan Africa.





# 2000s

In the 2000s, we helped establish the Jubilee 2000, an international coalition campaigning to cancel \$100 million of debt in the global South.

In 2004, we helped get food, shelter and healthcare to more than 500,000 people after the Asian Tsunami.

# **2010s**

Throughout the 2010s, we campaigned at UN climate talks for the biggest polluters to pay up for causing the climate crisis and the subsequent loss of life, land and culture around the world.

# Leaving any size of gift in your Will can make a big impact

Gifts in Wills make up more than a third of the voluntary donations given to Christian Aid. These gifts are from supporters who chose to transform their lifetime of hope into lasting change. Here are just a few stories from the people whose lives have been changed as a result.

#### Salamatu's story

Even before the Covid-19 pandemic, Salamatu Abdulhai struggled to feed, clothe and care for her household of eight on a low and irregular income.

During the pandemic, we implemented a rapid response project called NALPER with our partners. It supported vulnerable households like Salamatu's, safeguarding them from the impact of lockdowns.

Thanks to the project, Salamatu was able to access enough money to start her own business. This helped Salamatu to get her family through a really tough time. Now they have a stable source of income and daily meals.

A gift in your Will could help fund vital emergency responses like this, so that people in crisis can take their future into their own hands.

#### Elizabeth's story

Elizabeth Lornenge is a grandmother and widow who cares for her three grandchildren while managing diabetes. Elizabeth was sadly left in this difficult position, following the deaths of her daughter and her grandchildren's father.

With no source of income, Elizabeth cares for seven-year-old Mary, four-year-old Dookenger, and three-year-old Oryina thanks to the kind assistance she receives from neighbours like 18-year-old Sunny, who told us: 'I help her with daily activities and also with farming her land.'

When Covid-19 came to Nigeria, Elizabeth had no means to protect her young family from the virus. That was until global neighbours like you stepped up to send her a tailored hygiene kit. Essentials like soap, hand sanitiser, face masks and nappies meant Elizabeth could keep herself, Mary, Dookenger and Oryina safe.

A gift in your Will could help fund essential aid like this, that enables grandparents like Elizabeth to keep their grandchildren safe.

#### **Meet Denise**

Denise, a mother of seven who lives in Burundi, was deeply concerned for her children's health. She sought professional advice from a local health clinic called Agents of Change, that is funded by gifts in Wills. Denise's children were diagnosed with severe anaemia and received medical treatment.

Denise told us: 'After a while, my anaemic children, for whom the doctor had recommended a blood transfusion, recovered.'

'Thanks to the project I am doing well. I am giving a balanced diet to my children, and my household has been saved and is doing well economically'

Denise later joined the village savings and loans association, an economic empowerment programme that provides community members with the skills and support they need to grow their incomes. With guidance and a business loan, Denise bought a goat. She told us: 'A year later, my goats had multiplied to nine... I am very

happy. I participated in farming school and started to produce vegetables with my children. I set up a vegetable business thanks to a loan, which allowed me to buy sweet potato and beans that I mixed with vegetables to make balanced meals.'

As a result of the Burundi community project funded by gifts in Wills, nearly 2,500 households can now grow their own vegetables, and more than 3,800 women can access community schemes to pay for the essentials they need.

A gift in your Will could help kick-start a small business like Denise's, that changes the course of a family's future.



# Meet Jane, a Christian Aid supporter

Jane Brittin grew up in a family where world affairs were often discussed, and charitable work was a big part of life. From a young age, Jane helped her mother with door-to-door collections for Christian Aid, and since then, Jane has never looked back.

Jane has decided to remember Christian Aid in her Will, as a way to ensure her values will live on when she's no longer around.

# How to leave a gift in your Will

We understand that leaving a gift in your Will is an important decision. You may find it helpful to speak with family and friends first. If you have any questions, our friendly Legacy team are here to help you.

#### Three simple steps

1

#### Find a Will writing service

The Christian Aid Legacy team can't provide legal advice, so we recommend you speak with a solicitor or professional Will writing service that can meet your needs.

You could ask your friends and family for recommendations or find a local solicitor at **lawsociety.co.uk** 

Alternatively, you could make or update your Will for free with one of our Will writing partners, National Free Wills Network or Farewill. Of course, there's no obligation to leave a gift to Christian Aid when you use one of our partners, but we hope you'll consider doing so.

#### In person

#### Choose the type of gift you'd like to leave

There are three main types of gift that can be left in a Will:

- specific an object or property
- pecuniary a fixed amount of money
- residuary\* a share of your estate, the value of which is calculated after all other gifts and expenses have been paid.
- \*This is the most common type of gift left to Christian Aid. It enables you to take care of all your other beneficiaries and financial responsibilities first.

It's important to give our correct details to your solicitor or Will writer. They'll need our registered charity number and address as follows:

#### Appoint your executor/s

Your executor will be responsible for carrying out the instructions in your Will. You can appoint more than one. An executor can be any person you know and trust. They might be a friend, relative or your solicitor.

## **FAQs**

#### Why do I need a Will?

Your Will is your last opportunity to provide for the people and causes you've cared about in your lifetime. It's a legal document that expresses how you wish your property and money to be distributed after your death. Without a Will, your wishes might not be carried out.

#### What wording should I use in my Will?

We always recommend you seek the advice of a solicitor or professional Will writer regarding the best way to word your Will. However, you may find this suggested wording helpful: I leave £\_\_\_\_ / a \_\_\_\_% share of my residuary estate to Christian Aid, for its general charitable purposes and I declare that the receipt of the treasurer or other proper officer for the time being shall be a sufficient discharge to my executors.

# Will the gift in my Will be charged inheritance tax?

Your gift to Christian Aid will be exempt from inheritance tax, so it can help to reduce the tax burden on your other beneficiaries, such as family and friends. Your solicitor or professional Will writer can explain how to make your Will as tax efficient as possible.

# How much of my gift will go to people living in poverty?

Whatever the size, your gift will go to programmes that support families and communities to free themselves from poverty. Our supporters usually choose to leave us an unrestricted gift, so we can use it wherever the need is greatest. However, if there's a particular programme you'd like your donation to support, please get in touch with us and we'll be happy to discuss this with you.

#### Can I change my mind?

Yes, of course. You can change your Will by making an official alteration with a document called a codicil. You must sign a codicil and get it witnessed in the same way as you would a Will.





If you're considering remembering Christian Aid in your Will, thank you. You can be sure that your gift will be used wherever it is needed most, and your kindness will be felt for generations to come.

We understand that your Will can be a personal matter. However, letting us know about your intended gift can help us to plan our work more effectively. More importantly, it means we can thank you for your generous support in your lifetime.

Together, we WILL bring about the change we want to see in the world.
